



**Resolution No. AC/18/7:** Dr. Jagriti Upadhyaya raised one observation, that is last line of the recommendations of the committee be changed or deleted. The last line is reproduced as under: "The department of languages should focus on enhancement of communication skills in English (rather than English literature) to improve employability of students who largely have a background of academics in the vernacular language. Research (Ph.D.) in these departments should be discouraged or not undertake."

In view of the above observation, the committee member Dr. Gorakhnath Tiwari is of the opinion that the above statement has been written in the recommendation not with the intention of removing or discouraging the study/research of English language and literature in totality. It aims to highlight the fact that subjects which are not directly/indirectly associated with the aims objectives and ethos of this University should be given focus to the extent that they augment, enhance and enrich the study and research of the subjects which are specific to the overall aims and objectives of this University. Any deviation from this aspect will certainly lead to loss of man hours of teaching staff and unintentional deviation of the students from the intended spheres and areas of specialization and research.

Dr. Swikar Lama informed that earlier Police Studies was attached with the Department of Criminology and therefore Department of Criminology had been handling Police Administration courses. In the committee recommendation Police Administration is a sole department in the Faculty of Police Administration and Society and is attached with Sociology and History. The committee was of the opinion that keeping in view the objectives of the University the Faculty of Social Science and Humanities has been reassigned to Police Administration and Society which is more relevant to the subjects to be taught at Police University.

In conclusion the council agreed and approved the proposal as given in Annex II of the recommendation of the committee.
